Vitalizm Farms is committed to growing community and sustainability through growing delicious and gourmet food. We strive to develop soils that provide important ecosystems for all living things, including humans. We rely exclusively on ecological and biodynamic organic farming methods which beneficially promote and enhance biodiversity, biological cycles, and biological soil activity. The goal is to create tasty food and to maximize the nutritional value of the food we grow.

As a shareholder, you agree to share in the inherent risks of farming and agriculture, which include but are not limited to unforeseen diseases and pests; unusually severe weather such as prolonged heatwaves, drought, hail, strong winds, early frost, etc.; natural disasters such as tornadoes, fires and floods. However, you will also share in the rewards of a bountiful harvest resulting from optimal growing conditions and good farming practices.

## **Member Responsibilities:**

As a CSA member, you agree to pick up your shares at Vitalizm Farms, located at 7213 N. 115th Street, Longmont CO 80504 on pickup day. You agree to make special arrangements in advanced for a different pickup date and time, and agreed upon by Vitalizm Farms if the usual day doesn't work for that week's pickup. If for some reason you can't make that 2<sup>nd</sup> day, we will donate your share to Our Center. I don't anticipate this happening but want to have contingencies.

## **Payments, Refunds and Cancellations:**

Both CSA members and Vitalizm Farms have the right to cancel this agreement at any given time and for any given reason. Cancellation by the shareholder prior to the first day of share distribution, will result in a full refund minus a \$10 administrative fee. Cancellation by Vitalizm Farms prior to the first day of share distribution will result in a full refund.

Cancellation requests by a shareholder at any given time during the duration of this CSA agreement will result in a prorated refund for the remaining weeks of unclaimed shares, minus a \$10-dollar administrative fee. Cancellations by Vitalizm Farms during the duration of this CSA agreement will result in a prorated refund for the remaining weeks of unclaimed shares.

Payment is due immediately after submitting a signed agreement. We accept checks, credit cards, debit cards, and cash. Our preferred payment methods are cash or check. Payments by credit card will incur a \$9-dollar transaction fee (which is just the cost of the credit card transaction). Please make checks payable to **Vitalizm Farms**.
